The U.S. Department of Agriculture has evidence that on or about the date(s) listed below, you or your organization committed violations of the following sections of the Code of Federal Regulations, Title 9:

Date(s): August 27, 2015

§2.31(d)(1)(i) – Institutional animal care and use committee (IACUC).

IACUC review of activities involving animals. In order to approve proposed activities or proposed significant changes in ongoing activities, the IACUC shall conduct a review of those components of the activities related to the care and use of animals and determine that the proposed activities are in accordance with this subchapter unless acceptable justification for a departure is presented in writing; *Provided, however,* That field studies as defined in part 1 of this subchapter are exempt from this requirement. Further, the IACUC shall determine that the proposed procedures involving animals will avoid or minimize discomfort, distress, and pain to the animals.

§2.33(b)(2) – Attending veterinarian and adequate veterinary care. (DIRECT)

Each research facility shall establish and maintain programs of adequate veterinary care that include the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries, and the availability of emergency, weekend, and holiday care.

Date(s): August 27, 2015

§2.33(b)(3) – Attending veterinarian and adequate veterinary care. (DIRECT)

Each research facility shall establish and maintain programs of adequate veterinary care that include daily observation of all animals to assess their health and well-being; *Provided, however,* That daily observation of animals may be accomplished by someone other than the attending veterinarian; and *Provided, further,* That a mechanism of direct and frequent communication is required so that timely and accurate information on problems of animal health, behavior, and well-being is conveyed to the attending veterinarian.

Date(s): August 27, 2015

§2.33(b)(5) – Attending veterinarian and adequate veterinary care.

Each research facility shall establish and maintain programs of adequate veterinary care that include adequate pre-procedural and post-procedural care in accordance with current established veterinary medical and nursing procedures.
