Externally this chimpanzee is in good physical condition. The abdomen is distended and on palpation notable tympany can be elicited. There is a small amount of vomitus in the mouth and the cervical air sacs, that is blood tinged. There are numerous superficial lacerations to both hands - acquired post-mortem from cage mates.

Gas audibly escapes the abdominal cavity on incision. The intestinal tract to length is gas filled, particularly the transverse colon. There are many adhesions to the intestinal tract to the stomach and body wall. The serosal surface of the jejunum is reddened and thin walled. The gall bladder is full. The pancreas is reddened, however this is consistent with post mortem changes. The liver is smaller than would be expected. The lungs, heart and spleen as well as the kidneys are grossly unremarkable. There is a small amount (10ml) of sero-sanguinous fluid free in the abdomen.

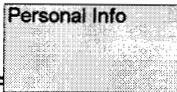
